Teacher candidates engage in supervised field experiences from the outset of the UAFS School of Education program, culminating in a comprehensive internship. Placement decisions aim to deliver high-quality clinical experiences, balancing the needs of the candidate, university supervisor, mentor teacher, K-12 partner schools, and the School of Education to ensure robust classroom preparation. Candidates may request preferred internship schools within the university's designated service area, but placements are not guaranteed. The Teacher Licensure and Field Placement Coordinator collaborates with K-12 administrators to co-select placements, considering the candidate's prior experiences, school support levels, available programs, staff training, and opportunities to work effectively with diverse student populations. UAFS follows the Arkansas Department of Education policies when making decisions about placements.

1. Teacher candidates develop lessons that embrace diversity, integrating these lessons into teaching simulations and real-world classroom interactions with students. 2. Throughout the program, candidates are assigned to diverse settings, engaging with varied populations—such as those with socioeconomic challenges, special needs, diverse ethnicities, and limited English proficiency—before their culminating internship, ensuring a broad range of experiences. 3. Every course in the curriculum explicitly incorporates diversity, as evidenced in faculty syllabi and reflected in assessments at both college and university levels. 4. Candidates are evaluated on their use of effective teaching strategies for diverse learners, with assessments tied to the academic progress of P-12 students impacted by their instruction, and data indicate candidates successfully embed diversity in their lesson plans. 5. Candidates are placed in diverse classroom environments, where they gain experience working with limited English proficient students under

the supervision of a mentor teacher<sup>6</sup>. The School of Education has adopted the Aspiring Teacher Rubric, training all candidates in effective teaching standards. This aligns with Arkansas's TESS Framework, the mandated evaluation system for public school teachers and the mentoring model for first-year educators, ensuring UAFS graduates are well-versed in the state's evaluation and mentoring processes, which administrators value for its seamless preparation. 7. The School of Education has established a Recruitment Plan to strategically enhance efforts to attract candidates from diverse populations. 8. To address teacher shortages, the School of Education collaborates with local schools to offer a paid residency program, providing practical experience for candidates.

Candidates have opportunities to learn about the online format for classroom teachers with our school partners. 2. Candidates videotape themselves teaching a lesson in the public school classroom. They watch the video and complete a self-evaluation. The instructor gives the candidate formative evaluative feedback. 3. Most education faculty completed a course in Full-Online, Hybrid or Web-enhanced technology. 4. Every syllabus must show how technology is being embedded and specifically used in coursework. 5. All education candidates complete a course in educational technology that requires them to plan activities that require K-12 students to use technology in their own learning. Candidates are introduced to the ISTE Standards in the course. A major unit assessment is completed in the course, and it is aligned with the ISTE Standards. 6. Interns complete a technology project that requires them to construct lessons in which K-12 students use technology to enhance their own learning. 7. UAFS School of Education candidates must design and deliver lessons that explicitly address how they meet the needs of diverse learners, including students with disabilities. Using a provided class profile, candidates tailor their planning and teaching to ensure inclusivity for all students. They complete special education coursework, engaging in case studies that deepen their understanding of supporting students with disabilities. During their internship, candidates are placed in diverse classrooms, collaborating closely with mentor teachers to implement effective instruction for all learners. At each stage, candidates are assessed on their ability to successfully engage and support students with varied needs, ensuring readiness for inclusive classroom environments through the Aspiring Teacher Rubric.

#### b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Candidates are invited to attend IEP meetings through their embedded placements in the school districts. They are expected to demonstrate knowledge of the role of the teacher in this type of meeting. Candidates also participate in mock parent-teacher conferences where they are expected to demonstrate knowledge of the role of the teacher in this type of conference, providing data to support student learning and making recommendations for students with diverse needs. During the internship, candidates participate in IEP meetings as the classroom teacher does.

Every pedagogy course in the UAFS School of Education integrates discussions and assignments focused on supporting students with limited English proficiency (LEP). Candidates are assigned to diverse clinical placements throughout the program, where they engage with LEP students under the guidance of a mentor teacher. These placements provide valuable opportunities for candidates to apply and refine strategies for effectively teaching LEP students, fostering inclusive and equitable classroom practices.

The Executive Director of the School of Education is charged with leading the School of Education and reports to the Dean of CHEHS. The secondary education programs are housed in the College of Arts and Sciences. The School of Education also offers a 3-4 endorsement for those who have a K-6 teaching license. The School of Education is an embedded model program that utilizes the Professional Learning Community model. The School of Education continues to expand partnerships with embedded courses in area K-8 partner schools for Elementary and Middle-level programs. UAFS is located in a culturally diverse area, which presents both challenges and successes. Poverty is also a major challenge for both our K-12 students, and for our candidates who come from low socio-economic backgrounds. Despite financial challenges, many UAFS School of Education candidates recognize education as the pathway to a brighter future.
